
OUR PROGRAMS

United States of America (1991) Assist low-income children and families with crisis intervention, school supplies, food, and clothing, coordinate disaster relief, repair homes for shut-ins, and provide extensive child, teen, and community safety education



Guatemala (1991) Operate clinics, schools, Mothers Clubs for abandoned and widowed women, orphan support and foster care, Casa Jackson Hospital for Malnourished Infants, Scheel Center for Academic Excellence and Vocational Training



Malawi Africa (2001) Installed deep-water fresh-water community wells, built residential schools for AIDS orphans, established poultry co-op for AIDS-widowed women and their dependents

The GOD'S CHILD Project is fully committed to fiscal simplicity, responsibility, and transparency. 91% of all donated dollars go directly to help the poor that we serve.

The GOD'S CHILD Project is externally and independently audited annually by Betz, Goldman, Clearfield, Kramer & Ocampo, LLP. In Guatemala and El Salvador, the Project and dependent programs are audited externally and independently audited annually by Moore Stephens International. In addition, the Project is assisted by senior charitable, tax, and management advice by pro bono professional accountants at BDO International and other firms.

- GlobalGiving international review, visitation, and approval


Best Practices Policies

Special GCP Foundation and Endowment Accounts Note


During FY2015, The GOD'S CHILD Project and The GOD'S CHILD Project Foundation (a separate entity) merged into just The GOD'S CHILD Project. Our Foundation's fund value of \$ 876,419 was received by The GOD'S CHILD Project and deposited into three permanently restricted endowment accounts created for this purpose with American Trust Center of Bismarck, ND. The GOD'S CHILD Project receives a 5% annual distribution of assets from these funds.
